Cristina Caffarra, Vice-President, Charles River Associates




Dr Cristina Caffarra heads up the Competition Team of Charles River Associates (a team of consulting economists) in Europe. Dr Caffarra holds a PhD in Economics from Oxford University and is an expert in the

application of applied theory and industrial economics to competition law, as well as the empirical analysis of markets in the context of competition investigations. She has provided economic advice to companies on landmark cases in merger control, assessment of vertical restraints, finding of dominance, evaluation of abusive conduct, and several other competition / antitrust issues including bundling, tying, rebates, price discrimination, other forms of potentially exclusionary conduct, intellectual property rights, information exchanges, collusion and the assessment of damages.

She has directed and coordinated empirical and theoretical economic analyses on several of the high profile cases of the last 20 years before the European Commission (including matters involving Microsoft, Amazon, Google, Samsung, Hollywood Studios, Sky and others), the competition authorities of several member states as well and the Courts in several jurisdictions. She has provided expert economic advice and testimony before the General Court in Luxembourg, the Competition Appeal Tribunal in the UK, the High Court in Dublin, the Competition Appeals Tribunal in South Africa, and various courts in several litigated competition matters.

Dr Caffarra has worked for research institutions both in Italy and at Oxford. She is on the Editorial Board of the European Competition Law Journal, as well as on the Advisory Board of the Journal of European Competition Law & Practice (OUP). She lectures in competition economics and has published articles for competition journals as well as presented papers on the economics of competition law at numerous international and academic conferences.

José Luís Cruz Vilaça, Judge, Court of Justice of the European Union



Born 1944; degree in law and master's degree in political economy at the University of Coimbra; Doctor in International Economics (University of Paris I - Panthéon Sorbonne); compulsory military service performed in the

Ministry for the Navy (Justice Department, 1969-72); Professor at the Catholic University and the New University of Lisbon; formerly Professor at the University of Coimbra and at Lusíada University, Lisbon (Director of the Institute for European Studies); Member of the Portuguese Government (1980-83): State Secretary for Home Affairs, State Secretary in the Prime Minister's Office and State Secretary for European Affairs; Deputy in the Portuguese Parliament, Vice-President of the Christian-Democrat Group; Advocate General at the Court of Justice (1986-88); President of the Court of First Instance of the European Communities (1989-95); lawyer at the Lisbon bar, specialising in European and competition law (1996-2012); member of the Working Party on the Future of the European Communities' Court System - 'Due Group' (2000); Chairman of the Disciplinary Board of the European Commission (2003-07); President of the Portuguese Association of European Law (since 1999); Judge at the Court of Justice since 8 October 2012.

Isabelle de Silva, President, Autorité de la Concurrence



Isabelle de Silva was appointed president of the Autorité de la concurrence on October 14, 2016 by decree of the President of the French Republic.

Isabelle de Silva is a member of the Conseil d'Etat, the French supreme administrative

court, which she joined in 1994 after graduating from Ecole des Hautes Etudes Commerciales (HEC-1990), the Community of European Management Schools (CEMS-1990), the Sorbonne University in philosophy (Paris I-1989)

and Ecole Nationale d'Administration (ENA-1994), the French national school for civil service.

After holding different positions as auditeur (1994) and then maître des requêtes (1998) at the Conseil d'Etat, she became commissaire du gouvernement at the Second and then Sixth Chamber of the Conseil d'Etat (2000-2009), and was later promoted to the rank of conseiller d'Etat (2009) and president of the Sixth Chamber (2013).

She was an adviser to the Minister of Culture and Communications, in charge of the press and the radio (1999-2000), director of legal affairs of the Ministry of Ecology, Sustainable Development, Transport and Housing (2009-2011), and became a member of the sector regulator for press distribution in 2012.

She has, in addition, been a member of the board of the Autorité de la concurrence since 2014. Isabelle de Silva is an Officer of the French Légion d'honneur, ordre national du Mérite and ordre des Arts et des Lettres.

Miguel de la Mano, Executive Vice President, Compass Lexecon Brussels Office



Dr. Miguel de la Mano is an Executive Vice President in Compass Lexecon's European competition policy practice, based in Brussels.

Before joining Compass Lexecon, Miguel de la Mano was Head of Economic Analysis

and Evaluation at DG Internal Market. Since 2012, he led a team of experienced financial economists in support of the EU Commission's unprecedented regulatory overhaul of EU banking, insurance and financial markets.

Miguel joined the European Commission in late 2000 as a competition economist. In 2003 he became a member of the newly created Chief Economist Team. He was appointed Deputy Chief Economist in early 2009. From October 2011 to May 2012 he was Acting Chief Economist at the UK Competition Commission.

He has co-drafted guidelines setting out the European Commission's analytical framework on merger control,

vertical and horizontal agreements (Article 101) as well as single firm conduct (Article 102). He also co-drafted "guidelines on the submission on economic evidence" for DG COMP and the "new market investigation guidelines" for the former UK Competition Commission.

Over the last fifteen years he has been closely involved in dozens of in-depth merger and antitrust investigations, at the fact finding, analysis, and decision making stages. He has defended the EU Commission in several court proceedings and provided economic testimony to EU Courts in several high profile antitrust and merger cases. He has written articles on EU competition policy and financial market regulation, with the aim of shaping and guiding EU enforcement and policymaking.

He completed graduate studies in economics at the Institute for World Economics in Kiel, Germany, and the European Institute at Saarbrucken University, Germany. He conducted his PhD research at Oxford University, UK.

Ariel Ezrachi, Slaughter and May Professor of Competition Law, Oxford University



Ariel Ezrachi is the Slaughter and May Professor of Competition Law at the University of Oxford and the Director of the University of Oxford Centre for Competition Law and Policy. He is the co-editor-in-chief of the Journal of

Antitrust Enforcement (OUP) and the author, co-author and editor of numerous books, including Virtual Competition – The Promise and Perils of the Algorithm-Driven Economy (2016, Harvard) and EU Competition Law, An Analytical Guide to the Leading Cases (6th ed, 2018, Hart). Professor Ezrachi's research and commentary have been featured in The Economist, The New Yorker, Wall Street Journal, Financial Times, The Guardian, Nikkei, New Scientist, Politico, WIRED, BBC, and other international outlets.

Giulio Federico, Head of Unit, Chief Economist Team, DG Competition, European Commission



Giulio Federico is Head of the Unit in the Chief Economist Team (CET) of DG Competition, European Commission. He joined DG Competition in late 2011. Over the past few years he has coordinated the CET's work on numerous in-

depth merger investigations and on several antitrust matters. Prior to joining the European Commission he worked in economic consultancy for 10 years and was a Vice President at Charles River Associates. He is a guest Professor at the Barcelona Graduate School of Economics, and was the President of the Association of Competition Economics in 2014 and 2015. He holds an MPhil and a DPhil in Economics from the University of Oxford (Nuffield College). He has published a number of academic and policy papers, on merger-related issues (e.g. efficiencies; remedy design; quantitative methods; bidding markets; and innovation) and on other competition topics (e.g. loyalty discounts; and regulatory and competition issues in energy markets).

Harry First, Charles L. Denison Professor of Law, New York University (NYU)



Harry First is the Charles L. Denison Professor of Law at New York University School of Law, where he has taught since 1976, and is Co-Director of the law school's Competition, Innovation, and Information Law

Program. He was twice a Fulbright Research Fellow in Japan and taught antitrust as an adjunct professor at the University of Tokyo. From 1999-2001 he served as Chief of the Antitrust Bureau of the Office of the Attorney General of the State of New York. Professor First's recent scholarly writing includes a study of the Microsoft litigation, The Microsoft Antitrust Cases: Competition Policy for the

Twenty-first Century (co-authored with Andrew Gavil), the casebook Free Enterprise and Economic Organization: Antitrust (co-authored with John Flynn and Darren Bush), and various book chapters and law review articles. Professor First is a contributing editor of the Antitrust Law Journal, foreign antitrust editor of the Antitrust Bulletin, a member of the Executive Committee of the Antitrust Section of the New York State Bar Association, a member of the Advisory Board and a Senior Fellow of the American Antitrust Institute, and a Fellow of the Innovators Network Foundation.

Peter Freeman CBE QC (Hon), Chairman, Competition Appeal Tribunal



Peter Freeman CBE, QC (hon) is a Chairman of the UK Competition Appeal Tribunal. From 2011-2013 he was Senior Consultant to the international law firm Cleary Gottlieb Steen & Hamilton. From 2005-2011 he was Chairman of the UK Competition Commission, having been a Deputy

Chairman since 2003.

Prior to that he practised for 30 years at the international law firm Simmons & Simmons, 25 of them as a partner, managing the Commercial Department and heading the EC and Competition Law practice group. He is a member of the Lloyds Enforcement Appeal Tribunal Panel, Chairman of the Appeals Committee of the Human Fertility and Embryology Authority and a non-executive member of the SSRO (Single Source Regulations Office).

Peter Freeman was for many years Chairman of the Regulatory Policy Institute, Oxford, and has written and spoken widely on competition and regulatory law. He is a member of the Advisory Board of the International Competition Forum, University of St Gallen and the Scientific Board of Concorrência e Regulação, Lisbon.

Richard Gilbert, Emeritus Professor of Economics, University of California at Berkeley



Richard Gilbert is Emeritus Professor of Economics at the University of California at Berkeley. From 1993 to 1995 he was Deputy Assistant Attorney General in the Antitrust Division of the U.S. Department of Justice, where he led the effort that developed joint Department of

Justice and Federal Trade Commission Antitrust Guidelines for the Licensing of Intellectual Property. Professor Gilbert's research specialties are in the areas of competition policy, intellectual property, and research and development. Professor Gilbert served as Chair of the Berkeley Economics Department from 2002 to 2005, President of the Industrial Organization Society from 1994 to 1995, and the non-lawyer representative to the Council of the Antitrust Section of the American Bar Association from 2011 to 2014. He is the author of numerous research papers and has testified before Federal and State courts and regulatory agencies and the U.S. Congress. He holds a Ph.D. in Engineering-Economic Systems from Stanford University and Bachelor of Science and Master of Science degrees in Electrical Engineering from Cornell University.

António Gomes, Acting Deputy Director, OECD Directorate for Financial and Enterprise Affairs



Antonio Gomes is currently Acting Deputy Director of the OECD Directorate for Financial and Enterprise Affairs, temporarily interrupting his functions as Head of the OECD Competition Division for which he

was appointed in November 2016. He has been President of the Portuguese Competition Authority (2013-2016), having previously served as a Senior Competition Expert in the OECD's Competition Division in 2013.

Prior to joining the OECD in 2013, he was Director of the Merger Department of the Portuguese Competition Authority. Since 2005, he has been an Assistant Professor at the Universidade de Aveiro, Portugal.

Antonio Gomes holds a Doctorate Degree in Economics from the University of York, United Kingdom, and Master Degrees in Economics from the University of York and the Universidade Nova de Lisboa.

Frederic JENNY, professor of Economics at ESSEC Business School (Paris) holds a Ph.D in Economics from Harvard University (1975), a Doctorate in Economics from the University of Paris (1977) and an MBA degree from ESSEC Business School in Paris (1966)

He is the Chairman of the OECD Competition Committee (since 1994), Co-Director of the European Center for Law and Economics of ESSEC (since 2010) and Chair of the Commission for Deontology of the French Federation of Insurance Companies (since 2016). He is also an economic and legal consultant.

He was previously:

Non-Executive Director of the Office of Fair Trading in the United Kingdom (2007-2014),

Judge on the French Supreme Court (Cour de cassation, Economic Commercial and Financial Chamber) from 2004 to August 2012, Vice Chair of the French Competition Authority (1993-2004), President of the WTO Working Group on Trade and Competition (1994-2003)

He was visiting professor at Northwestern University Department of Economics in the United States (1978), Keio University Department of economics in Japan (1984), University of Capetown Business School in South Africa (1991), Haifa University School of Law in Israel (2012), University College London Law School (2005-2012) and was Global Professor of Antitrust in the New York University School of Law's Hauser Global Law School (2014 and 2017). He was Appointed Senior Fellow in the Online Global Competition and Consumer Law Master's Program, University of Melbourne (Jan1 2016 to 31 December 2018).

He is member of the editorial board of several scientific journals ("Concurrences", "Journal of Competition Law and Economics", "World Competition"), member of the advisory board of the "Interdisciplinary Center for Competition Law and Initiative, Middle East Initiative" and Chairman of the scientific board of Consumer Unity Trust of India (CUTS).

Frederic Jenny is an officer in the order of the Legion of Honor from France, an officer in the order of Merit from France and a knight in the order of the Star from Romania.

Johannes Laitenberger, Director-General, DG Competition, European Commission



Johannes Laitenberger is the Director-General of the European Commission's Directorate-General for Competition. He took office on 1 September 2015. Under the political guidance of Commissioner Vestager, he manages the Directorate-General within the framework set by its

mission statement and work programme.

He has been Deputy Director-General of the Commission's Legal Service (2014-15), Head of Cabinet of President Barroso (2009-14), Spokesperson of the European Commission (2005-09) and Head of Cabinet of Commissioner Reding (2003-04).

Margarida Matos Rosa is President of the Portuguese Competition Authority (Autoridade da Concorrência - AdC), since November 2016.

Her previous professional experience includes, in the public sphere, the Portuguese Securities Markets Commission (CMVM) and, in the private sector, BNP Paribas and UBS Bank.

Margarida Matos Rosa holds an undergraduate degree in Economics from Université Catholique de Louvain (Belgium) and an M.P.A. from Princeton University.

Maria João Melícias, Member of the Board, Autoridade da Concorrência (AdC) – Portuguese Competition Authority



Maria João Melícias is member of the Board of the AdC since May 12, 2014. Prior to her appointment, she was a "référendaire" at the Court of Justice of the European Union, in Luxembourg.

Massimo Motta, Professor of Economics, Barcelona Graduate School of Economics



Massimo Motta is Research Professor at ICREA - Universitat Pompeu Fabra, and Research Professor of the Barcelona Graduate

School of Economics. He founded the GSE's Competition and Market Regulation Programme and he is in the Steering Committee of this Master.

He served as Chief Competition Economist of the European Commission from 2013 to 2016.

Prof. Motta's main areas of research are industrial organisation and in particular competition policy. His work, widely cited and influential, has been published in the leading international economic journals. His book on Competition Policy: Theory and Practice (Cambridge University Press, 2004) is the standard international reference on the economics of antitrust, and is used by teachers, scholars, and practitioners. He has recently published a new book on Exclusionary Practices. The Economics of Monopolisation and Abuse of Dominance (Cambridge University Press, 2018) with Chiara Fumagalli and Claudio Calcagno.

He has extensive experience in advising competition agencies on cases and policy, in teaching competition policy (to lawyers, economists, agency officials, and in both undergraduate and graduate courses) and in supervising doctoral dissertations. His former students have obtained important positions in academia, consulting firms, and in competition and regulatory agencies.

Professor Rose received her Ph.D. in Economics from MIT and an A.B. in Economics and Government from Harvard University. Her accomplishments have been recognized by numerous fellowships over her career, including those from the Alfred P. Sloan Foundation, Center for Advanced Study in the Behavioral Sciences, Hoover Institution, John Simon Guggenheim Foundation, and National Science Foundation. Her professional service includes terms as Vice President and Executive Committee member of the American Economic Association (AEA), and service on corporate, mutual fund, and nonprofit Boards of Directors.

Before beginning his academic and government career Mr. Shelanski was a law clerk to Justice Antonin Scalia of the United States Supreme Court, Judge Louis H. Pollak of the U.S. District Court in Philadelphia, and Judge Stephen F. Williams of the United States Court of Appeals in Washington D.C. Mr. Shelanski earned his Ph.D. in economics and his J.D. from the University of California at Berkeley, and his B.A. from Haverford College.

Jacques Steenbergen, President, Belgian Competition Authority



Prof. em. Dr. Jacques Steenbergen (born in Antwerp (Belgium) in 1949) is since its establishment as an independent authority in 2013 president of the Belgian Competition Authority. He was from 2007 to 2013
