

# AdC Achievements Jan 2020-Jul 2021

## **Competition Enforcement**

A total of €397 million in 9 sanctioning decisions, including disqualification from participation in public tenders.

### Investigation and sanctioning of anti-competitive practices

#### 9 sanctioning decisions:

- o Cartel in railway maintenance, with a €1.8 million fine imposed and a subsequent disqualification from participating in public tenders in the railway maintenance sector, for a period of two years.
- Hospital Particular do Algarve fined with €155,000 for acquiring sole control of Hospital de S. Gonçalo de Lagos S.A. without prior notification of the acquisition (gun-jumping).
- Fine of €3.6 million to APAP (Portuguese Association for Communication and Marketing Agencies) for restraining its associates from freely participating in procurement tenders for advertising services.
- Fine of €84 million on the telecommunications operator MEO (Altice) for market sharing and price fixing of mobile and fixed telecommunications services with NOWO – Communications.
- o Total fine of €304 million on six large food retail chains, two beverage suppliers, a board member and a director for price fixing of the suppliers' products. The first decision adopted by the AdC concerns hub-and-spoke practice between Modelo Continente, Pingo Doce, Auchan and Intermarché, as well as supplier Sociedade Central de Cervejas (SCC), a SCC board member and a business unit director of Modelo Continente. In a second decision, the AdC fined the same four large food retail chains (Modelo Continente, Pingo Doce, Auchan and Intermarché), as well as Lidl and Cooplecnorte (E. Leclerc), for concerted pricing through spirits supplier Primedrinks.
- National Association of Land Surveyors (ANT, in Portuguese) sanctioned with €50,000 for restricting competition in the market of land surveying services, by fixing prices for these services.
- Natus Medical Incorporated fined with €100,000 for restricting competition in the distribution of essential medical devices in the Portuguese market.
- Blueotter and EGEO sanctioned with a fine of € 2.9 million for implementing a non-compete agreement in the market for the provision of services to waste management systems in Portugal.

- o In security and surveillance services, seven companies for taking part in a cartel in public tenders
- In real estate fund management, Fidelidade SGOII, for gun-jumping
- 718 complaints received and handled.
